Universal Business Design (UBD) will provide the Subscriber with the following services:

- i. UBD will send, via e-mail, a custom designed newsletter to each individual on the Subscriber’s subscription list one time per month.
- ii. UBD will manage the newsletter as follows:
  - a. Add new prospects provided by the Remodeler/Subscriber and manage the recipient database.
  - b. Coordinate and create the graphic design of the newsletter template so that it has the look and feel of an original publication created by the Subscriber.
  - c. Design and format the newsletter as a full color HTML email with photo(s), company name, logo, signature and other contact information as desired by Subscriber. The design will coordinate the graphic look and feel of the Subscriber’s web site or other branding look.
  - d. Provide original articles written by industry professionals as content for the newsletter.
  - e. Distribute the newsletters via email on behalf of the Subscriber one-time per month.
  - f. Provide a space in each edition of the newsletter for the Subscriber to add his or her own unique message and upload a photograph from his/her computer.
- iii. **Subscriber agrees not to reproduce, archive, reuse, or republish the articles contained in the newsletter in any form, or to make the content available to the general public, either in electronic or hard-copy format. UBD retains full copyright to the articles in the newsletter, and promises that all content for the newsletter is original and has been written exclusively for the newsletter.**

**UBD promises to never use any of the names on the subscriber's mailing list for any purpose other than adding those names to the subscriber's database.** This includes contact via email, phone, mail or any other way to contact subscriber's database list. In addition, UBD agrees to never sell, rent or give away the list or any part of the list to any third party. UBD understands and honors the fiduciary relationship concerning subscriber email addresses. UBD manages the Subscribers list as a service and convenience. In addition this allows UBD to help insure that Subscribers do not use the newsletter to send out 'blanket spam'.

**Cost:** The cost of the Newsletter is \$195 per month. Design fees and start up fees are waived.

Pro-rated payment will be charged upon the execution of this agreement. Payments received mid-month will be pro-rated.

Monthly payments will be drawn on the 1<sup>st</sup> day of each month and subscriber fees are paid via credit card.

The Subscriber or UBD may cancel this agreement at any time by providing the other party written notice of the cancellation. Email is acceptable. If cancellation is made mid-month, final month's fees will be prorated.
